#### DC Fast Charging Update

The Sacramento region has **over 50 DC Fast Charging EV refueling plazas** already installed or under construction. Many of the newer chargers are over 100 kW. There is a 350kW charger that will go live in the next few months. You'll be able to find it near Target in the Rocklin Commons. Tesla Model 3 now works with CHAdeMO via an adaptor from the Tesla Store. The free "[Drive The ARC](#)" [DC Fast Charging program](#) is still up and running with over 30 stations participating.

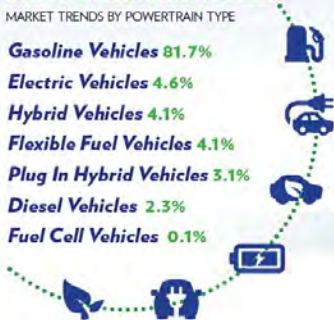

#### EV Sales in Sacramento Region

Showing your EV and sharing your electric driving experience with the community is working!

I estimate that there are currently **28,000 EVs on the road in our region**. The California New Car Dealers Association [reported](#) that EVs were **7.8% of new car sales in 2018**. We saw a similar EV uptake rate in the Sacramento region.

**The good news keeps on coming.** As reported by [Clean Technica](#), the public is taking notice. The Union of [Concerned Scientists](#) and Consumer Reports recently surveyed Americans planning to buy a new car within the next 2 years. Over a third of the respondents said they are definitely planning to, or would consider, buying/leasing an EV for their next purchase. Another 27% would consider one at some point down the road. This is consistent with a recent J.D. Power survey which found 39% were likely to purchase an EV.

Yet two-thirds of consumers in the J.D. Power survey say they have no experience with battery-electric vehicles. These folks can benefit from our EV activities. We have been making a difference in our communities and it's important that we continue doing so.

The UCS / CR survey added clarity on who's considering EVs. Interest in EVs is not limited to high income buyers.

- 39% of respondents who earn more than \$100K a year are considering an EV for their next purchase
- 39% of those with incomes between \$50K to \$99K a year are considering an EV for their next purchase
- 31% of those making under \$50K a year also indicated an interest in purchasing an electric car.
